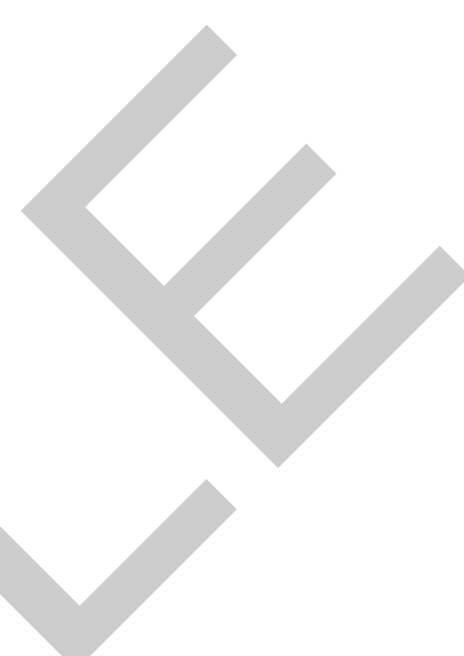

To vote for the candidate of your choice, complete the arrow to the **RIGHT** of the candidate's name. To vote for a person whose name does not appear on the ballot, write the person's name on the line(s) provided and complete the arrow to the **RIGHT** of the line.

When voting for president or vice president, you may vote only for the candidates on one ticket jointly or by writing in the names of persons in both spaces. A write-in vote only for a vice presidential candidate will not be counted.
