**Instructions for Voting**

- 1 Press the button  to the right of the candidate of your choice. A green "X" will appear next to your selection.
- 2 To change a selection, press the button  again. The green "X" will disappear and you may make a new selection.
- 3 To vote on a Public Question, press the button  to the right of the word "YES" or "NO." A green "X" will appear next to your selection.
- 4 If you wish to cast a WRITE-IN vote, go to the PERSONAL CHOICE column and press the button next to WRITE-IN across from the office you wish to write-in. Using the alphabetical keyboard below, enter the name of the person of your choice, one letter at a time. To make a space between the first and middle name or initial and last name, use the arrow pointing to the right on the keyboard. To make a correction, use the arrow pointing to the left. The name you enter will appear in the display to the left of the keyboard. Prior to pressing **enter** for a write-in vote, be sure you have verified the spelling of the person's name and you have selected the correct office. Your choice is recorded and removed from the display.  
**WARNING:** If instructions for a write-in vote are not followed exactly, then you have an improperly cast write-in vote, which will be void and not counted.
- 5 After ALL selections have been made, press the RED CAST VOTE BUTTON located in the lower right corner. This electronically records all of your votes.
- 6 Part the curtains and exit the voting booth.  
Before entering the machine, if you have any questions about voting, ask the Poll Clerk.

**ATTENTION VOTERS!**

Familiarize yourself with this ballot and instructions. It will assist you in voting, and save time on election day.  
**IMPORTANT:** All voters who can should vote early in the day and thus avoid the possibility of congestion and inconvenience to themselves and others near the close of the polls.

PUBLIC QUESTIONS TO BE VOTED UPON	
<p><b>STATE PUBLIC QUESTION No. 1</b> <b>Building Our Future Bond Act</b></p> <p>Do you approve the "Building Our Future Bond Act"? This bond act authorizes the State to issue bonds in the aggregate principal amount of \$750 million to provide matching grants to New Jersey's colleges and universities. Money from the grants will be used to build, equip and expand higher education facilities for the purpose of increasing academic capacity.</p> <p><b>INTERPRETIVE STATEMENT</b></p> <p>Approval of this act will allow the State to issue bonds in the total principal amount of \$750 million. Proceeds from the bonds will be used to provide grants to New Jersey's public and private colleges and universities to construct and equip higher education buildings to increase academic capacity.</p> <p>Bond proceeds will be allocated as follows: * \$300 million for public research universities; * \$247.5 million for State colleges and other State universities; * \$150 million for county colleges; and * \$52.5 million for private institutions with an endowment of \$1 billion or less.</p> <p>Public and private colleges and universities which receive grants will be required to provide funds to support 25% of a project.</p>	<p>YES <input type="checkbox"/></p> <p>NO <input type="checkbox"/></p>
<p><b>STATE PUBLIC QUESTION No. 2</b> <b>Constitutional Amendment Allowing Contributions To Be Taken From Justices' And Judges' Salaries For Their Employee Benefits</b></p> <p>Do you approve an amendment to the New Jersey Constitution, as agreed to by the Legislature, to allow contributions set by law to be taken from the salaries of Supreme Court Justices and Superior Court Judges for their employee benefits?</p> <p><b>INTERPRETIVE STATEMENT</b></p> <p>This amendment clarifies the Legislature's authority to pass laws requiring contributions be taken from the salaries of Supreme Court Justices and Superior Court Judges for their employee benefits. These benefits include their pension and health care coverage.</p> <p>The amendment responds to a question raised in a 2011 lawsuit filed by a judge after the Legislature passed and the Governor signed into law P.L.2011, c.78. That law increased the contributions taken from current and future justices' and judges' salaries for their benefits, starting in October 2011. The lawsuit, which was appealed to the New Jersey Supreme Court, argued against taking the higher contributions from currently appointed justices and judges, citing language in the Constitution that their salaries cannot be reduced during their appointed terms.</p> <p>The amendment clarifies that such contributions, set by law, may be taken from justices' and judges' salaries during their terms.
